SUBJECT: CHARGING AND COLLECTING REQUIREMENTS FOR

MEDICAL CARE SERVICES RENDERED

POLICY NO. 520

PURPOSE::

To establish requirements for charging and collecting for medical care

services rendered.

POLICY::

Each Departmental facility shall charge and pursue collection for all health care services provided at Departmentally established rates in accordance with the provisions of Departmental policies, the County's reduced- cost health care programs (e.g., Ability-To-Pay Plan (ATP), Outpatient Reduced-Cost Simplified Application (ORSA), Pre- Payment Program) and other programs (e.g., Medi-Cal, Medicare, Short-Doyle, California Children's Services, Child Health and Disability Prevention, Alcohol and Drug, etc.).

GUIDE::

Charges assessed for health care services provided shall be pursued for collection from all available third-party payers, other granting agencies (e.g., Queens Care, Ryan White, etc.) and patients within existing legal, regulatory, contractual, and policy constraints.

EXCEPTIONS::

Exceptions to this Policy are only as provided in the following Departmental Policies numbers 521 through 525.

DEFINITIONS::

These definitions are applicable to Policies numbers 520 through 525.

<u>Third Party Payers</u> means Federal and State funded programs, insurance companies, health plans, employers (Worker's Compensation), third party tortfeasors, etc., which have a contractual or legal obligation to pay for an

individual's medical services.

Other Granting Agency means Governmentally administered or other agencies which reimburse the County, through grant or contract, for health care services provided by the Department to the agency's beneficiaries.

<u>Patient</u> means the patient and responsible relatives, defined as spouse and parents, if the patient is a minor child.
