<u>PURPOSE</u>

To describe a process of how a youth may comment and receive a response about the quality of health care received.

<u>POLICY</u>

All youth have the right to question or complain about the health care that they receive. JCHS will appropriately address those complaints and provide a resolution to the youth.

Probation is responsible for processing grievances according to their existing policies and procedures.

PROCEDURE

- Youth are informed and oriented to the grievance process at admission.
- Youth are assisted in completion of the grievance forms by the probation officers.
- Grievances are collected by the Probation Grievance Officer who will forward the type of grievance to the respective departments.
- Health care grievances are forwarded to the facility's Nurse Manager for review and disposition within 72 hours excluding holidays and weekends.
- JCHS responses will be forwarded back to the Probation Grievance Officer.
- The responses will also be sent to the JCHS Medical Director or designee who will track and trend them for reporting to the JCHS QI Committee.
- Youth will have the opportunity for appealing the response
 - a. Reference Probation Department's Detention Services Bureau Manual/Residential Treatment Services Bureau Manual – Grievance Procedures
 - b. In summary, Probation Grievance Officer will review the response with the youth who will either agree or appeal the response.
 - c. If a youth appeals the response, the Responsible Health Authority will be contacted to assist with the appeal process with the Superintendent/Facility Director for a decision.
- The Grievance Officer will have the youth sign the Grievance Form to close the grievance.
- After signature, the Grievance Officer will include the Responsible Health Authority when submitting the form for filing.
