SUBJECT: PARKING

POLICY NO. 120

PURPOSE:

To establish a uniform policy and procedure regarding the allocation, privileges and responsibilities of parking on Harbor-UCLA Medical Center grounds and to ensure a safe environment for Harbor's patients, visitors and workforce members.

POLICY:

The Medical Center provides free parking for patients, visitors, staff (workforce members, students, & volunteers), in parking lots on and near the campus. Designated parking areas shall be restricted during certain hours, and may require a facility-issued parking permit. Open parking shall be provided on a first-come, firstserved basis. The Medical Center shall provide a shuttle service during scheduled hours. The hospital is not responsible for damages to or loss sustained by vehicles parked on the premises.

DESCRIPTION:

Open Parking – All areas on campus that are not posted restricted. Open Parking lots are as follows:

Locations: Lot A (West of Surgery/Emergency)

N-25/Paint Shop (Normandie Avenue entrance onto Medical Foundation Drive)

Lot V (826 W. 220th Street southeast corner of Vermont & 220th Streets)

Lot D (3rd level of parking structure, southeast corner of campus)

Restricted Parking - Designated and authorized/medical personnel parking.

Locations: Lot B - Patients, visitors, hospital volunteers (Hospital Way main entrance; west on North Drive).

Lot C (North) - Patients, visitors, hospital volunteers (Hospital Way main entrance; east on

North Drive).

Lot C (South) - Police parking, Reserved (24-hour) and Carpool parking. (Vermont Avenue

entrance).

Lot D (Parking Structure levels 1 and 2) - Faculty/Volunteer Attending Physicians, House staff and Authorized Personnel (220th St entrance, near Vermont Avenue), restricted to providers,

restricted hours from 06:00 a.m. to 2:00 p.m.

- Reserved Parking 24-hour approved designated parking (Lot C South) (Vermont Avenue entrance).
- Carpool Parking Workforce members Carpool hanger permit parking (Vermont Avenue entrance) (Lot C South and Lot V at 826 W. 220th Street), 6am 2pm Monday Friday.
- Shuttle Services Shuttle transportation for patients, visitors and staff throughout the campus and to off-site campus parking lots. See section E below for shuttle hours.

PROCEDURE:

A. Open Parking – All campus parking areas are available to staff, visitors and patients except in areas that are designated parking as described in sections B and B.1 and C below. All legal signage must be observed.

Carpool Permit hangers issued to eligible employees at Building N32 by ETC,

C. Reserved Parking:

Location: Lot C (South) - Hospital Administration approves assigned reserved parking spaces 24-hours/7 days-per-week.

D. Employee Carpool Parking:

Permit carpool parking available to employees that commute to Harbor's campus with two or more passengers per vehicle. Carpoolers must complete a carpool application with the Employee Transportation Coordinator at Environmental Health & Safety, (Building N-32), (424) 306-7733.

Carpool hangers must be in full view in the front windshield. Carpool hangers are shared with registered carpool group and are non-transferable. Lost carpool applications are not processed by mail and hangers are not replaceable until annual re-issuance.

Vehicles parked in the carpool area without displaying appropriate hanger will be cited and may be towed away at owner's expense.



Vehicle Citations:

- 1. Written parking citations are issued by LASD and will be placed on the vehicle's windshield.
- 2. Vehicles parked in restricted areas without displaying appropriate placard i.e., permit, current hangtag, disabled, etc., or parked in unmarked parking stalls and no-parking areas may be cited and/or towed away at owner's expense.
- 3. Workforce Members who park their vehicles in unauthorized areas may be cited and or towed away at owner's expense.
- 4. Restricted parking lots will be monitored.
