PURPOSE

To ensure that a system exists to review, monitor and maintain the quality of nursing care that is provided to all patients within the LAC+USC Medical Center.

POLICY

Nursing Quality Management (NQM) under the guidance of the Nurse Clinical Council (NCC) provides a written plan for directing the quality control and improvement activities of the Department (refer to Nursing Policy, "Quality Control/Improvement Plan"). Nursing Quality Management also approves and assists with the application of nursing research as it affects the LAC+USC Medical Center, and reviews and approves articles for publication that reference the Medical Center (refer to Nursing Policy, "Nursing Research/Grants").

RESPONSIBILITY

Oversight

- The overall responsibility and authority for assuring that quality nursing care is provided resides with the Chief Nursing Officer.
- The Clinical Nursing Directors (CND's) are responsible for area quality assurance/improvement activities. The CND's report to NCC findings which may include but are not limited to:
 - Addressing corrective actions
 - Unusual occurrences
 - Quarterly reports
 - Safety Intelligence events including falls, pressure injuries, assaults, and harm scores of 6 or higher.
- The NCC has the responsibility for developing and directing the Nursing Department Quality Management Plan and for evaluating the Quality Assurance/Improvement activities of the Department of Nursing. The Chief Nursing Officer delegates to the Chairperson.

This council is a standing council of the Department and provides representation to the Quality Improvement Committee (QIC).

- Assist units in performance improvement projects
- Produce reports for Clinical Nursing Directors so they can direct their department's quality improvement projects or develop corrective action plans
- Complete audits identified by the Clinical Nursing Directors to assist in evaluating compliance of their departments
- Work with the Clinical Nursing Directors to assist in educating staff in areas determined as
 deficient based on audits or citations
