SUBJECT:	LOOK-ALIKE, SOUND-ALIKE MEDICATIONS		

## POLICY:

Formulate a list of look-alike/sound-alike (LASA) medication combinations and address special precautions or procedures for ordering, dispensing, and administering drugs with look-alike or sound-alike names and measures to prevent medication errors.

## PROCEDURE:

- 1 Prescriptions should clearly specify the dosage form, drug strength, and complete directions. Whenever possible and necessary, indications should be included on outpatient prescriptions and on inpatient PRN orders.
- 2 Whenever possible and necessary, the purpose of the medication should be determined prior to dispensing or administering the medication.
- 3 Name alert stickers for look-alike/sound-alike medications will be utilized in the Pharmacy as needed.
- 4 Look-alike/sound-alike medications will be segregated from their counterparts in designated colored bins. The exception is in the Inpatient Pharmacy where the bins will have "Look-Alike/Sound-Alike" labels in the Talyst system.
- 5 Two independent checks will be used for look-alike/sound-alike medications in the Pharmacy.
- 6 Error and potentially hazardous conditions with look-alike/sound-alike product names will be reported to the physician, physician assistant, or nurse practitioner, forwarded to Pharmacy, and shared at the P&T Committee meetings.
- 7 The list will be reviewed and revised as appropriate on at least an annual basis.
