### PURPOSE:

To ensure adequate number of qualified faculty to support program needs.

### POLICY:

Faculty teaching assignments are based on, but not limited to:

- Student needs
- Number of students
- Faculty qualifications
- Number of faculty.

#### Faculty are:

- Remediated to new clinical areas prior to reassignment
- Encouraged to have more than one area of clinical expertise.

All new and remediated faculty are approved by the California Board of Registered Nursing (BRN) for clinical content area and classification.

New faculty must be approved by the BRN prior to employment.

Faculty are responsible for assigned theory content, clinical supervision, and other responsibilities needed to meet course and student needs.

### PROCEDURE:

The SON Dean/designee:

- Projects the number of students:
  - Enrolled in each semester/course
  - Progressing from one course/semester to the next
  - Repeating the course/semester
  - Assigned to each ward/facility.
- Assigns/reassigns faculty to courses/semesters based on:
  - Faculty qualifications, experience, workload
  - Program needs
  - Open/available faculty positions

#### Subject: FACULTY TEACHING ASSIGNMENTS

- Provides faculty with a minimum of two weeks notice prior to reassignment.
- Faculty may make written requests for course/clinical/semester reassignment.

Semester Coordinators:

- Assign faculty to theory courses and clinical groups as required for achievement of course and program objectives based on:
  - Course schedules
  - Available clinical sites
  - Faculty workload.
