PURPOSE

To ensure compliance with regulatory requirements for birth verification.

POLICY

All live born newborns delivered within the hospital shall be registered within 24-72 hours of delivery. A completed record of verification of birth shall be provided to the Office of Vital Statistics 10 days of delivery, in accordance with State law.

PROCEDURE

- Each infant shall receive health/medical record number (MRN) and shall be identified as a hospital patient.
- The hospital shall complete and file the necessary preliminary verification of birth record. Birth
 certificates shall be issued by the Department of Health Services Office of Vital Statistics in
 accordance with State law.
- The parent and/or family representative shall review and sign the hospital birth record form.
- In the event, that the parent and/or family representative is not available to sign the birth certificate record, the hospital designee may sign the form.
- The attending physician or midwife shall sign, date, and enter title and license in accordance with the law. EXCEPTION: In the absence of the physician, the Hospital Administrator or his/her designee shall be authorized in writing to sign the birth certificate verifying the fact of birth.
