**POLICY:** Renders professional medical services to patients as part of a Medical Student

Educational Program.

CLASSIFICATION STANDARDS: Positions allocable to this class are responsible for providing medical care and treatment to a variety of patients during the medical student education in the Department of Emergency Medicine.

**PURPOSE:** To delineate the job description of the Medical Student.

**DEPARTMENTS: DEPARTMENT OF EMERGENCY MEDICINE (DEM)** 

**DEFINITIONS:** The job description for the Medical Student.

**PROCEDURE:** 1. To provide patient care in the Emergency Department under the

supervision of the attending physician by assessing and reassessing each patient's need. This includes but is not limited to history, physical exam, diagnostic studies, admissions/discharge from the ED, and aftercare

instructions.

- 2. Dress appropriately and wear an OV-UCLA Medical Center ID Badge.
- 3. All cases must be presented to the attending and an attending will be present during all pelvic examinations.
- 4. The attending will review all patients presented by the student at the patient's bedside.
- 5. The attending will try to focus on pertinent history and physical findings.
- 6. The patient's rights and expectation will be respected at all times.
- 7. Types of patients seen by the student will include but not limited to the following:
  - Chest Pain
  - Abdominal Pain
