SUBJECT/TITLE: CYT - 34 - CYTOTECHNOLOGIST WORKLOAD LIMIT AND PERFORMANCE EVALUATION

PRINCIPLE: To document the protocol for establishing a maximum slide examination workload and evaluation of a cytotechnologist's performance at Olive View Medical Center Department of Pathology.

POLICY: PURPOSE:

The performance evaluation is based on feedback on the cases referred to the pathologist, quarterly QA of 10% interpretation data and performance at interlaboratory comparison programs. The results of the performance evaluation are used by technical supervisor to determine the maximum number of slides a cytotechnologist is authorized to examine in a 24-hour period.

DEPARTMENTS: PATHOLOGY

DEFINITIONS:

RESPONSIBILITIES: Laboratory Director:

Responsible for the overall operation and administration of the laboratory including oversight of the cytotechnologist productivity and performance evaluation

Technical Advisor (pathologist, MD); in conjunction with the direct supervisor.

- Is accessible to provide consultation to resolve technical problems
- Reviews cytotechnologist workload data
- Reviews quality assurance data for a cytotechnologist
- Establishes workload limits, as needed
- Reviews and discusses any discrepancies with the cytotechnologist in response to identified quality assurance issues
- May give additional assignments to the cytotechnologist within scope of the job description, as needed

Cytotechnologist:

- Records slide interpretation results of each case examined

Records total number of slides examined for each 24 hour period _

- Records the number of hours spent examining slides in each 24 hour period

PROCEDURE:

Daily workload

- The workload limit is determined by technical supervisor and is reassessed at least every 6 months
- The maximum number of slides should not exceed 80 per 24 hour period -
- The maximum number of slides may be examined in no less than an 8-hour _ screening period

Performance evaluation includes, but is not limited to, the following:

- Comparison of the cytotechnologist's interpretation of non-gynecologic specimens to the final diagnosis. If the case has false negative interpretation, the cytotechnologist is encouraged to review the cases with original sign out pathologist.
- Quarterly review of 10% of random cases with interpretations by a cytotechnologist and comparison with final diagnosis (reviewed by pathologists).
- Participation in interlaboratory comparison programs -
