### **PURPOSE**

To clarify the responsibility of Sheriff's Deputies and Sheriff's Security Officers (SSO) providing security and law enforcement services for the LAC+USC Medical Center.

# **POLICY**

The Sheriff's Deputies and SSO's are responsible for law enforcement in or about the LAC+USC Medical Center facilities; to prevent harm to patients, visitors, and employees; and to prevent the theft and loss of property.

## **PROCEDURE**

The Los Angeles County Sheriff's Department shall operate 24 hours, seven days a week; services include but are not limited to:

- Provide continuous security surveillance of Medical Center facilities' grounds.
- Conduct vehicle and foot patrols of facility areas and off site campuses.
- Investigate criminal activities; interview victims, witnesses, and suspects.
- Conduct traffic and crowd control.
- Conduct activities that prevent the loss of property due to theft.
- Write crime and injury reports; issue misdemeanors, traffic, and parking citations; and testify in court.
- Maintain facility statistical information
- Arrest, transport, and book suspects.

- Respond to requests from other departments.
- Provide emergency response to manage access to facilities.
- Conduct in-service training to all employees in all departmental and Medical Center training aspects of terrorism, employee workplace violence, bomb threats, and The Joint Commission regulations regarding their responsibilities in the areas of security and bomb threats.
- Assisting outside law enforcement personnel in interviewing/photographing patients not in custody.
- Collaborating with local police agencies to maximize the policing efforts to detect and suppress crime, apprehend suspected criminals, and recover property.

The Medical Center Chief Executive Officer's designee shall maintain an active liaison with LASD personnel on all matters of security for the LAC+USC Medical Center.
